- 1 Please complete your choice of Season Ticket on the Season Ticket Member application form.
- 2 Complete this Payment Plan Application form including the direct debit mandate and ensure that you sign the direct debit mandate where applicable.
- 3 Return both forms along with the initial deposit to the Ticket Office, Hibernian Football Club, Easter Road Stadium, 12 Albion Place, Edinburgh EH7 5QG.
- 4 The remaining instalment will then be collected by direct debit. No Payment Plan Applications forms will be accepted without payment of the initial deposit.
- 5 Allowable methods of payment for the initial deposit are debit/credit card, cheque or cash. However, cash will only be accepted for applications made in person at the Ticket Office. CASH SHOULD NOT BE SENT BY POST. The initial deposit by postal applications can only be made by debit/credit card or cheque.
- 5 **Closing date for Payment Plan Applications (accompanied by the initial deposit) is 9 December 2011.**
- 6 **Final instalments will be taken by direct debit on 1 Feb 2012.**

TERMS AND CONDITIONS

1. On receipt of the initial deposit Hibernian Football Club Limited ("the Club") agrees to collect one payment on 1 February 2012.
2. The terms of this agreement shall include all the terms and conditions of issue of a season ticket by the Club to the Season Ticket Member.
3. You warrant that the information provided by you to us is correct and authorise such investigation or enquiry about you that we may wish to make.
4. You acknowledge that you have read all the terms of this Agreement before signing it and have received a copy of this Agreement.
5. You agree to pay us the instalments set out above.
6. We will supply you a Season Ticket Membership Card. You agree to keep the Card in a secure manner and not lend it to others to use - the Card is not assignable. We shall be entitled to inspect and take away for examination the Card at any time.
7. This Agreement must be signed by you.
8. You shall notify us of any change of address, or contact telephone number, whether temporary or permanent.
9. If you, the Season Ticket Member:
 - a. Fail to comply with the terms of this agreement; or
 - b. Fail to pay to the Club a payment on the due date for payment; or
 - c. Fail to maintain a direct debit mandate
 Then and in any such event you, the Season Ticket Member, agrees to:
 - d. The Club denying the Season Ticket Member access to the stadium
 - e. The Season Ticket remaining in the ownership of the Club until fully paid
 - f. The Season Ticket Membership being resold at the discretion of the Club
10. These terms will be governed by and construed in accordance with Scots Law and the Scottish Courts will have non-exclusive jurisdiction to hear all disputes arising in connection with the terms.
